Anne Husted Burleigh is a free-lance writer from Cincinnati. She is the author of a biography, *John Adams*, and of articles and essays which have appeared in *Modern Age*, *Intercollegiate Review*, and other publications. Mrs. Burleigh also edited a volume on the future of private education in a free society. She holds degrees in history from DePauw and Indiana Universities.

Jude P. Dougherty, Dean of the School of Philosophy of The Catholic University of America, is also editor of *The Review of Metaphysics*. A specialist in social and political philosophy and in the history of American philosophy, he has recently edited the volume *The Good Life and Its Pursuit*. Dougherty is a past president of the Metaphysics Society of America, The American Catholic Philosophical Association, and the Society for the Philosophy of Religion.

Arthur M. Eckstein, an assistant professor in the Department of History at the University of Maryland, College Park, received his Ph.D. from the University of California at Berkeley in 1978. His interest in George Orwell derives from a course that he teaches on "Freedom and Authority."
